Freight Defense, LLC will ship all replacement, or repaired, products to Customer, FOB Freight Defense's shipping point.

d. Freight Defense will honor a 30 day return policy from date of purchase (proof of purchase required). Please note, all returns will be subject to a 25% restocking fee and product must be in good working order and free from defects. Freight/shipping charges are not included in the return policy. Customer is responsible for all freight/shipping charges with respect to product returns. In order to make a warranty claim, please contact Customer Service to receive a Return Merchandise Authorization (RMA) Number.

e. Factory support is only available for Freight Defense products purchased as new through an Authorized Freight Defense dealer. Please Note: Freight Defense products purchased on auction sites such as Ebay and Craigslist, to name a few, will not be covered under factory warranty under any circumstance.
