2007-2018 Jeep Wrangler JK Locking Fuel Door w/Combination Lock



Reset code before lock installation!

Step 1: How to Reset or Code Combination Lock

- 1. Combination should be set to default code of (7-7-7)
- 2. With the default or last code set and in the unlocked state, insert combination tool into hole on the bottom of lock and press reset button.
- 3. While holding the reset button in, set the new 3-digit combination code and then release button and remove tool.
- 4. Test lock for proper operation.
- Step 2: Remove left taillight using Philips head screw driver.
- Step 3: Disconnect the taillight electrical connector and place aside the taillight and screws for reinstallation.
- Step 4: Remove the fuel cap and disconnect the fuel cap tether.
- Step 5: Remove the fuel filler housing by reaching in through removed taillight opening and release the housing retentions clips while pulling the assembly from the outside.
- Step 6: Remove rubber filler neck grommet from factory housing and install on the Pop and Lock fuel door housing. Be sure to notate the orientation of the grommet.
- Step 7: Trim the correct unused locator pin so it is flush with the new housings plastic surface, file if necessary to get
- Step 8: Install the PL3010 housing while pressing the rubber grommet over the fuel filler neck.
- Step 9: Line up the untrimmed locator pin with the hole in the sheet metal and continue to press the assembly into place while holding the filler neck in position.
- Step 10: Check that all connecting clips clip onto vehicle sheet metal by pressing outward on the each of the clips.
- Step 11: Reinstall the fuel cap and snap the fuel cap tether back into place.
- Step 12: Reconnect the taillight electrical connector and reinstall taillight.
- Step 13: Check that fuel door opens unimpeded and works smoothly.
